**ORDER**

For smooth functioning of Mizoram State Lottery and as per approval of GAD vide I.D. No. GAD 136/2018 dt. 4.7.2018, the Asst. Resident Commissioner, Government of Mizoram, New Delhi and Caretaker, Mizoram House, New Town, Rajarhat, Kolkata are hereby authorised to receive printed Lottery Tickets on behalf of Director, IF&SL from the Press and to despatch them to the Distributors in the State of Punjab and West Bengal respectively as per terms and conditions indicated below and until further order:

**TERMS AND CONDITIONS**

1. He may be designated as "Officer on Special Duty" Mizoram State Lotteries.
2. He may be paid honorarium @ Rs. 5000/- per month or as decided by the Government from time to time which is to be borne by the Director, IF&SL.
3. Conveyance Expenditure or any other contingent Expenditure incurred in connection with performing his duties as OSD will be re-imbursed by the Director, IF&SL.

**DUTIES AND RESPONSIBILITIES**


He may perform the following duties and responsibilities in addition to his normal works.

1. To receive the Lottery Tickets from the Security Printing Press.
2. To check the tickets with reference to the printing order issued by Director, IF&SL and give a certificate to the effect that "the tickets are received in full and in good condition" in the body of the delivery challan.
3. Original copy of the delivery challan may be submitted to the Director.
4. To issue acknowledgement receipt to the press with a copy to Director, IF&SL.
5. To issue the tickets to the distributors or selling Agents for sale in the market.
6. To maintain a proper record of tickets indicating name of schemes, date of draws, quantity date of receipt and date of issue etc.
