EXPRESSION OF INTEREST

Sealed Expression of Interest (EOI) are invited in plain paper from reputed suppliers/firms for supply and installation of Air Blown Vacuum Draw Machines to conduct online draws of Mizoram State Lotteries.

Terms & Conditions:

- The interested suppliers/firms should submit their financial proposal inclusive of freight, delivery, installation and all taxes with F.O.R, Aizawl, Mizoram to the office of the Director, Institutional Finance & State Lotteries, Department of Finance, Government of Mizoram, Aizawl on or before 12:00 PM of Dt.21.10.2024 and will be opened on 21.10.2024 at 1:00PM
- 2. The supplier/firm shall also submit their Memorandum & Articles of Association of the company and the Registration Certificate or any other legal documents.
- 3. The Machines are to be supplied, installed and commissioned in the office of the Director, Institutional Finance & State Lotteries, Department of Finance, Government of Mizoram, Tuikhuahtlang, Aizawl, Mizoram, 796 001 by the Supplier.
- 4. The period of Warranty of the draw machine shall be clearly indicated by the bidder and also for the repair and part replacement and provision for onsite service.
- 5. The technical specifications of the Machines are attached at **Annexure A.**
- 6. The bid should be accompanied by a refundable Earnest Money Deposit (EMD) of Rs. 5% of the price of the Machines in the form of Demand Draft to be drawn on any Scheduled/Nationalized Bank having its Bank Branch at Aizawl in favour of the Director, Institutional Finance & State Lottery.
- The Earnest Money Deposit (EMD) of the unsuccessful bidders will be returned after the finalization of the contract agreement. The EMD of the successful bidder will be returned after submission of the Performance Security.
- 8. Within15 days of receipt of the notification of contract award, the Supplier shall furnish Performance Security to the Purchaser for an amount of 10% of the Contract Value, valid up to 60 days after the date of completion of performance obligations including Warranty obligations.

- 9. The Performance Security shall be furnished in the form of an account payee Demand draft, Fixed Deposit Receipt from a commercial bank, Bank Guarantee from a commercial bank or online payment in favour of the Director, Institutional Finance & State Lottery in acceptable form safeguarding the purchaser's interest in all respects.
- 10. The price should be quoted in figure and in words and must be inclusive of all taxes and other charges, etc. No claim for taxes/charges will be entertained at a later stage. Nothing over and above the quoted price would be payable to the successful bidder. Nothing over and above the quoted price would be payable to the successful bidder. Any overwriting/cutting etc should etc should be initialed with date.
- 11. The incomplete and conditional Expression of Interest (EOI) received after the prescribed date and time shall summarily be rejected.
- 12. The Bid Evaluation committee duly constituted by the Department/Office shall evaluate the bids and submit the report for consideration of DPAB.
- 13. Any litigation that arises due to this invitation of EOI shall be settled at Aizawl, Mizoram.
- 14. The Director, Institutional Finance & State Lotteries, Government of Mizoram reserves the right to accept or reject any expression of interest without assigning any reason thereof.
- 15. All works carried out should be guaranteed for standard life of the respective part and defects during this period will have to be carried out immediately on priority basis.
- 16. Spare parts, if any, to be replaced should be genuine/original part. All replaced spare parts will have to be returned to the Department/Office.
- 17. The Purchaser, in order to satisfy itself can order on the spot enquiry to verify the soundness & capability of the item and any other information given by the tendering firms.
- 18. The declaration that bidder has not been blacklisted by any Govt. agency within and outside Mizoram and abroad during last 5 years. The tender will be rejected straight way without assigning any reasons if the firm is found involved in any criminal case, declared blacklisted by any Govt./Semi Govt. department/agencies etc.

19. The bidder has an obligation to disclose to the Department/Office any situation of actual or potential conflict that impacts its capacity to serve the best interest of the Government. Conflict of interest for the

purpose of this contract will be as defined in Appendages Section 3.2 of the Mizoram Public Procurement

Rules, 2020.

20. The successful bidder may, if required, be invited for negotiations. The negotiation shall include both the

Technical and Financial aspects, such as the services to be provided, the terms and conditions of the

contract, the tax liabilities of the bidder etc. However, the negotiations shall not substantially alter the

scope of services under the Terms of Reference. After the completion of the negotiations, the successful

bidder shall promptly sign the Agreement/Contract with the Department/Office.

21. The payment will be made on receipt/acceptance of store in good condition as per prescribed

specification. No advance payment will be made. No claim for interest in case of delayed payment will be

entertained by the Department.
